Eligibility:

- Resident of Mid North Coast - Nambucca to Coffs Harbour (South of Woolgoolga)
- Open to all ages
- Staff and immediate family members of Mid North Coast Legal Centre and DA NSW are not eligible to enter

Open Date: 14 July 2021

Closing Date: 13 August 2021

Prize:

- AUD\$500 for Winner
- AUD\$250 for People's Choice

Submission:

All entries are to be submitted digitally (JPEG, PNG or PDF) to email info@mnlegal.org.au as detailed below:

- Completed and signed Mid North Coast Legal Centre 10 Year Anniversary Art Competition 2021 Terms and Conditions
- Photograph/s (no more than 3) of your artwork (works will be shortlisted from photographs)
- A written statement of up to 150 words describing how your work relates to the theme
- Use 'Art Competition' in the email Subject Header

Judging

- Works will be shortlisted by 5.00pm, 16 August 2021
- Owners of shortlisted works are required to deliver original works to Mid North Coast Legal Centre's office at 30 Murray Street Port Macquarie by 25 August 2021
- Shortlisted works will be on exhibition at our anniversary celebration on 26 August
- Winner and People's Choice will be announced on 26 August

MID NORTH COAST LEGAL CENTRE ART COMPETITION TERMS AND CONDITIONS

In signing this document, you agree to all the Terms and Conditions as detailed below.

All artists or parent/carer (for children under 18 years) are required to sign and submit the Terms and Conditions agreeing to the conditions.

Artwork must be original and the work of the submitting artist. Copyright in the artwork remains with the artist.

Artwork submitted after the closing date of 13 August will be ineligible for the competition.

The artist, as copyright owner, grants Mid North Coast Legal Centre and Advocacy Law Alliance Inc a non-commercial, non-exclusive licence to use the image for a two year period. Artists are permitted to use their submitted artwork for their own personal and/or business use.

Shortlisted entrants consent to Mid North Coast Legal Centre and Advocacy Law Alliance Inc. using images of the artwork, only for the non-commercial purpose of their promotional activities, for a period of 2 years.

Shortlisted works will need to be delivered to our Port Macquarie office (30 Murray Street Port Macquarie) before 26 August. Work will need to be collected from the office between 30 August to 10 September.

Prize organisers will insure the works while they are in their possession and control against theft, fire or damage. The entrants will be responsible for their works during transit to and from the exhibition.

The entrants will be formally recognised as the artist of the artwork whenever the artwork is displayed and used, including on the websites and social media of Mid North Coast Legal Centre and Advocacy Law Alliance Inc.

If the artwork contains ICIP, entrants are to inform the prize organiser of cultural attribution to be displayed alongside the works.

There will be ONE winner and ONE people's choice. The winner will receive \$500 and the people's choice will receive \$250. Prize money will be deposited into the nominated bank account of the prize winners. The decision by judges will be final.

No further or ongoing payment will be made by prize organiser other than the prize money
